7. Students must complete the minimum forty (40) hour pre-class assignments and show proof of doing so before the first day of an on-site session.

8. Students agree to read the provided training manual and workbook thoroughly once through and re-read the manual and workbook a second time. During the second reading, students agree to e-mail *Beauty EverLasting* questions she/he has regarding the information in each section. ***If student does not complete all 40 hours of pre-class studies prior to the start date, your classes will be rescheduled.*** Initial _____
9. It is understood that if I have any special needs required to complete the on-site portion of the class, I must notify *Beauty EverLasting* of these needs no later than two weeks in advance of the scheduled first day of class.
Example: latex allergy, non-latex gloves required. Initial _____
10. I understand that during class, the procedures I will be conducting are invasive. It is my responsibility to acquire the Hepatitis B series of immunizations prior to my class date, or I agree to decline the Hepatitis B inoculation process in writing. In any case, I hold *Beauty EverLasting* and/or her associates, and ***Beauty Everlasting*** harmless for any accidental exposure to Bloodborne pathogens during the on-site class session. 11. It is understood that prior knowledge of proper topical makeup artistry application is a necessary skill and that I either currently have, or will acquire these skills prior to the on-site class date that includes hands-on procedures. My class with *Beauty EverLasting* is contracted for the training and application of permanent cosmetics, not topical makeup artistry. On-site hand-on work will not be scheduled until the eyebrow drawing pre-class assignment project is completed to *Beauty Everlasting's* satisfaction. If for any reason the ability to draw a classic and symmetric eyebrow is not a talent you currently have, or one that is satisfactorily developed in the opinion of *Beauty EverLasting* during the pre-class study period, you will have two choices. 1. This will represent the end of the class without the benefit of refund, or 2. You will be required to relinquish eyebrow work in writing and focus on eyeliner work exclusively. This will be reflective on your procedure specific Certificate of Completion. Initial _____
12. Local students are required to arrange for a minimum of two models to bring to the class for hands-on work. *Beauty EverLasting* provides models if agreed upon. However, models provided by student ultimately help bring in business for the student, as they are more likely to be available for marketing purpose. This provision applies to local students only. Initial _____
13. Classes are limited to two students for practical work sessions, four for theory sessions. *Beauty EverLasting* supervises only one student at a time during hands-on work. If there are two students, one student will observe

the procedure or be assigned study work while the other student is conducting a supervised procedure.

14. Students agree to make themselves available to work with *Beauty EverLasting* on-site at specified dates & times agreed upon by both parties. **If student comes in late or leaves early, student will be required to make up hours lost at an additional cost at a rate of \$100/hour. All hours must be completed in order to receive Certificate of Completion.** If you are enrolling in a Flextime class, it is the responsibility of the student to contact *Beauty EverLasting* to arrange for a schedule for on-site sessions. If student cancels a scheduled training day, you will be required to make up that day at another scheduled date for an additional \$750.00.

15. *Beauty EverLasting* has informed me that it is advisable to master eyebrow, eyeliner, and lip liner procedures before proceeding into advanced procedures. (Such as full lip color, areola, etc...) These classes require advanced class study.

18. Students are responsible for their own transportation to and from class each day unless arrangements have been made with *Beauty EverLasting*. Lunch is off-site daily, and will be taken as time permits between hands on model assignments. Transportation is not necessary, as there is a good selection of local restaurants. Each student is responsible for his/her own housing accommodations for the duration of the class.

19. Students agree to follow all instruction provided through pre-class study directions and during class, and must work cohesively with fellow classmates and assistant trainers (if any). **Cell phones are not allowed in training classes.**

20. Each student is responsible for bringing a camera that he or she is familiar with, for taking before and after photographs of their hands-on work performed during class. It is the responsibility of the student to take photographs of work performed for portfolio purposes.

21. It is understood that I must finish all hours of training including pre-class and evening homework study assignments, complete the competency written testing at passing score of 75%, and perform satisfactory hands on procedures in order to receive a Certification of Completion for the class.

22. In the event models cancel their scheduled appointments, it is understood that the instructor will show permanent cosmetic videos, power point presentations or assign practical work.

23. If the class you are enrolling for is a fundamental permanent cosmetic course, it is your responsibility after the fundamental class to seek continuing education and advanced training as needed.

It is understood there is no guarantee of a “*Certificate of Completion.*” This certificate is awarded only if theory is reasonably understood and procedure specific design and practical work represents good techniques and results. *Certificate of Completions* will be awarded for the theory elements and practical work procedure types performed satisfactorily and once the proficiency examination is passed at a least a 75% level at the completion of the course. 25. *Beauty EverLasting* provides all post-class support for a period of one year via email or by phone at 732-627-5000 during regular business hours. Post-class support provisions do not include additional on-site class sessions at no charge. Initial _____
26. Each student is responsible for determining the licensing needs for their respective state & local municipalities. Initial _____
27. *Beauty EverLasting* provides an apprentice program (\$400.00/ session). If you are a New Jersey residents and opening a business in the state you are required by the state to take an apprenticeship to obtain a license. This includes a minimum of 5 of each of the following procedures: Eye brow, Lip liner; Full lip color and eyeliner/eyelash enhancer. Initial _____
28. *Beauty EverLasting* provides advanced training classes that include areola restoration, full lip and medical restoration /camouflage. These courses are not part of the Primary Training program. There will be an additional cost upon registration for these courses. Initial _____
